PROPOSAL: Amendatory and New Law

This measure creates the Oklahoma Innovation, Efficiency and Accountability Act of 2011. It allows state agencies to accept an electronic signature in the application process for any license or permit (excluding driver license renewal applications); it requires each state agency when filing their annual report and request for funds to include a detailed listing of all employees and resources dedicated to the provision of financial services; and it allows executive state agency employees to share leave time when the agency converts to the multi-monthly payroll system.

Attachment to Fiscal/Administrative Impact for HB 1207 (ENR) - prepared 05/23/11

Sections 1 and 2 - NEW and AMENDATORY

Section 1 creates the Oklahoma Innovation, Efficiency and Accountability Act of 2011. Section 2 allows state agencies to accept an electronic signature in the application process for any license or permit (excluding driver license renewal applications), if the use of an electronic signature does not create a significant risk to the integrity of the license or permit.

Section 3 – NEW

This section authorizes the Office of State Finance to maintain a website providing public access to the documentation of the disbursement by state agencies of federal funds received pursuant to the federal American Recovery and Reinvestment Act of 2009.

Section 4 - AMENDATORY

This section requires each appropriated state agency (except the Oklahoma State Regents for Higher Education and their institutions), when filing their annual report and request for funds with the Director of the Office of State Finance (OSF) and the Chair and Vice Chair of the Legislative Oversight Committee, to include a detailed listing of all employees and resources dedicated to the provision of financial services.

It requires the Director of OSF, by January 1 to publish a financial services cost performance assessment that documents each appropriated state agency's (except the Oklahoma State Regents for Higher Education and their institutions) cost for providing financial services. Agencies that rank in the bottom 10% of the cost performance assessment will be required to contract with OSF for the provision of shared financial services if the Director of OSF determines that it will result in cost savings to the agency;

Section 5 - AMENDATORY

This section allows executive state agency employees to share leave time, if approved by the appointing authority, when the agency converts to the multi-monthly payroll system.

Section 6 - NEW

This section requires copies of any audit, agreed upon procedure report or other attestation engagement report that is required to be filed with the State Auditor and Inspector to be submitted in electronic format and made available to the public on the Auditor's website.

Section 7 - NEW

This section directs the Superintendent of Public Instruction to publish on a website a listing of all expenses paid by the Department of Education necessary to sponsor or participate in meetings or training sessions and limits the amount of the cost of food for certain persons attending the meetings to the total daily rate provided for in the State Travel Reimbursement Act.

Section 8 – RECODIFICATION

This section 4 recodifies Section 41.5p-1 of Title 62 as Section 34.24.1 of Title 62.
