PROPOSAL: Amendatory and New Law

This bill proposes to amend 47 O.S. § 1135.3(B) by creating special license plates for persons wishing to demonstrate support for, or increase awareness of, Ovarian Cancer, BMW Car Club of America, Deer Creek School District and the "Don't Tread On Me" motto- as found on the historic Gadsden flag.

The bill also proposes to amend 47 O.S. § 1135.5(B) by creating special license plates for persons wishing to demonstrate support and provide financial assistance to Pancreatic Cancer Research. Alzheimer's Research, Hospice and Palliative Care and Juvenile Diabetes Research.

## Attachment to Fiscal/Administrative Impact for SB 200 (ENR) - prepared 05/17/10

Section 1 of this bill proposes to amend 47 O.S. § 1135.3(B) by creating special license plates for persons wishing to demonstrate support for, or increase awareness of, Ovarian Cancer, BMW Car Club of America, Deer Creek School District and the "Don't Tread On Me" motto— as found on the historic Gadsden flag

The annual fee for special license plates authorized by this section is \$15 and shall be in addition to all other annual vehicle registration fees. Eight Dollars (\$8.00) of the \$15 fee shall be deposited into the OTC Reimbursement Fund and the remaining \$7 shall be apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. § 1104.

Section 2 of this bill proposes to amend 47 O.S. § 1135.5(B) by creating a special license plate for persons wishing to demonstrate support and provide financial assistance to Pancreatic Cancer Research, Alzheimer's Research, Hospice and Palliative Care and Juvenile Diabetes Research.

The annual fee for special license plates authorized by this section is \$35 and shall be in addition to all other annual vehicle registration fees. Twenty Dollars (\$20.00) of the \$35 fee amount shall be apportioned as provided in Sections 3-6 (corresponding new law) of this bill, \$8 shall be deposited into the OTC Reimbursement Fund and the remaining \$7 shall be apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. § 1104.

The estimated revenue impact for SB 2000 (ENR) is minimal/positive. There is no estimated administrative impact associated with the proposed amendments.
