PROPOSAL: New Law & Amendatory 47 O. S. §§ 1135.2 & 1135.5

Section 1 proposes to amend 47 O. S. § 1135.2 creating a Legion of Merit Medal Recipient special license plate for any resident of Oklahoma presenting proper certification from the United States Department of Veterans Affairs or the Armed Forces of the United States of being awarded the Legion of Merit military decoration. Persons may apply for this special license plate for vehicles having a rated carrying capaity of one (1) ton or less.

Section 2 proposes to amend 47 O. S. § 1135.5 creating the Lupus Awareness and Education special license plate for any person wishing to provide financial support for the Lupus Foundation of Oklahoma.

Section 3 proposes to create a State Treasury revolving fund to be desginated the Oklahoma Lupus License Plate Revolving Fund to be administered by the State Department of Health.

ATTACHMENT TO FISCAL IMPACT-HB 1352-[SAHB]-Prepared April 18, 2013.

Section 1 proposes to amend 47 O. S. § 1135.2 creating a Legion of Merit Medal Recipient special license plate for any resident of Oklahoma presenting proper certification from the United States Department of Veterans Affairs or the Armed Forces of the United States of being awarded the Legion of Merit military decoration. Persons may apply for a Legion of Merit recipient license plate for vehicles having a rated carrying capaity of one (1) ton or less.

Such license plates shall be designed in consulation with the Military Department of the State of Oklahoma. The annual additional registration fee for this license plate is Eight Dollars (\$8.00) and shall be deposited in the OTC Reimbursement Fund.

Section 2 proposes to amend 47 O.S. § 1135.5 creating the Lupus Awareness and Education special license plate for any person wishing to provide financial support for the Lupus Foundation of Oklahoma. The annual fee for special license plates authorized by this section is \$35 and is in addition to all other motor vehicle registration fees. Twenty Dollars (\$25) of the \$35 fee amount fee shall be deposited into the Oklahoma Lupus Revolving Fund, \$8 shall be deposited into the OTC Reimbursement Fund and the remaining \$2 shall be apportioned as motor vehicle collections pursuant to the provisions of 47 O. S. § 1104.

Section 3 proposes to create a State Treasury revolving fund to be desginated the Oklahoma Lupus License Plate Revolving Fund to be administered by the State Department of Health.

The estimated revenue impact for HB 1352 is minimal/positive. There is no estimated administrative impact associated with the proposed amendments.
