**PROPOSAL:** Amendatory

Section 1 proposes to amend 47 O.S. § 1135.5 by creating a special license plate for any person wishing to provide financial support for the Sooner State ABATE and providing that the plate be designed in consultation with the referenced organization. It allows the special license to be issued to any person in any combination of numbers and letters from one to a maximum of seven, as for personalized plates. It further provides that as space permits the motorcycle special plate may be of similar design to the one for vehicles or a new design in order to meet the space requirements of a motorcycle license plate. The bill provides that a fee amount may be used for entering into any required licensing agreement for use of the organization's logo or design. It further states that the licensing agreement shall provide for a payment to Sooner State ABATE of not more than Twenty Dollars for each license plate issued.

## ATTACHMENT TO FISCAL IMPACT-SB 1277-[CS]-Prepared April 14, 2016.

Section 1 proposes to amend 47 O.S. § 1135.5 by creating a special license plate for any person wishing to provide financial support for the Sooner State ABATE and providing that the plate be designed in consultation with the referenced organization. It allows the special license to be issued to any person in any combination of numbers and letters from one to a maximum of seven, as for personalized plates. It further provides that as space permits the motorcycle special plate may be of similar design to the one for vehicles or a new design in order to meet the space requirements of a motorcycle license plate. The bill provides that a fee amount may be used for entering into any required licensing agreement for use of the organization's logo or design. It further states that the licensing agreement shall provide for a payment to Sooner State ABATE of not more than Twenty Dollars for each license plate issued.

The proposed -- if necessary -- \$20 licensing agreement payment amount to Sooner State ABATE for possible use of the organization's logo or design on each such special license plate issued would result in a corresponding \$8 deposit to the OTC Reimbursement Fund and any remaining amount of the \$35 fee apportioned as motor vehicle collections pursuant to the provisions of 47 O.S. § 1104.

Any estimated revenue impact will be minimal (positive in nature). There is no estimated administrative impact associated with the proposed amendment.
