PROPOSAL: Amendatory

The measure proposes amendment to Section 6-101 of Title 47 by providing that beginning July 1, 2022 and ending May 31, 2023 each motor license agent or licensed operator accepting driver license applications for qualifying 100% disabled veterans and for individuals over the age of 65 years shall receive \$6.00 for a four year driver license or \$12.00 for an 8-year driver license to be deducted from the motor license agent's or licensed operator's daily receipts. These retention amounts shall not be retained by any state agency. It further defines "licensed operator" to mean an individual who obtains a license from the Service Oklahoma Operator Board to operate a designated Service Oklahoma location and offers third-party fulfillment of designated services to be rendered by Service Oklahoma. Additionally, it proposes amendment to subsection (G) of Section 6-101 of Title 47 which relates to the parties responsible for the processing of applications for and issuance of REAL ID Complaint/Noncompliant Driver Licenses and Identification Cards.

REVENUE IMPACT

Currently, no statutory fee is imposed for qualifying 100% disabled veterans and persons 65 years of age and older to obtain a driver license. Based on CY 2021 Department of Public Safety ("DPS") data, 148,321 four year driver licenses were issued to the referenced groups. Eight year driver licenses became available beginning August of 2021. For August, 2021 through December, 2021, DPS data indicates that 61,780 eight year driver licenses were issued. Utilizing this data, a 12 month projection indicates a total of 148,272 eight year driver licenses related to the subject individuals.

Assuming similar driver license transactions for FY 23 as those experienced in CY 21, accounting for the proposed fees and adjusting for the 11 month application of the change results in a \$2,446,758 increase in motor license agent retention fees for FY 23. The measure directs that these amounts be deducted from the motor license agent's daily receipts. Consequently, a like decrease in motor vehicle collections will also occur for FY 23.

ADMINISTRATIVE IMPACT

Additional development costs to modify the motor vehicle system consistent with the proposed statutory changes are estimated in the amount of \$7,000.
